	We are a consortium of suppliers. According to 6.1.2 of tender regulations, all the members of the partnership shall be listed in Annex 1 "Application form" (we are not a registered partnership; we will enter into partnership agreement according to 6.1.2 (a), if our consortium/partnership will be awarded contracting rights). We have, however, defined the name that will be used for the consortium and need to clarify how our case should be correctly reflected in Annex 1. a) Considering the partnership is not registered, shall we provide, in Annex 1, the defined name of the consortium and, in brackets, registered/official name of each of its members, i.e. Consortium X (composed of company Z (leading consortium member) and company Y)? b) Considering the partnership is not registered, shall we provide, in Annex 1, registration number of each consortium member or just the registration number of the leading consortium	1. As per Clause 6.1.2 each of the members of the partnership has to be listed in application form by providing the same information which is requested for the Candidate;  a) There is no restrictions for format unless the provided information corresponds to the requirements. Yes you can provide name of the consortium, the name of the leading member and list all members;  b) Registration number of each consortium member has to be provided. It is advised to provide list of consortium members with detailed info as annex to the application (can be uploaded in section "Other documents" in E-Tender system), please note that it the Candidate relies on the resources or experience of other person in case when other person is consortium member, confirmation of cooperation (at least the letter of intention to enter into consortium (partnership) and passing the resources or experience (resources related to experience) signed by person who will forward the resources) shall be submitted;

- c) Considering the partnership is not registered, shall we provide addresses and contact information of each of its members or just the address and contact information of the leading consortium member?
- d) Considering the partnership is not registered, shall each consortium member's authorized representative sign the application form, or shall the application form be signed only by the authorized representative of the leading consortium member?
- c) Candidate has to indicate contact person (i.e. lead member of Consortium) who will be responsible for exchange of information in the consortium;
- d) Lead member of the consortium can sign the Application confirmation cooperation on (where the rights to sign the Application is assigned to one member) is submitted by each of the members of consortium or as a single document signed by all members of the consortium (agreement of cooperation) is submitted by Candidate. The confirmation of the cooperation has be signed by authorised representatives.
- Should the authorized representative of the candidate (i.e. authorized representative of group of suppliers) date and sign the Annex 3 or there is no such need for Annex 3?

There is no need of signing Annex 3. If the experience presented in the Annex 3 relates to different members of the consortium, the name of the member of the consortium should be indicated in the references.
